SURF BALLARD RULES AND GUIDELINES FOR SUP RENTAL

- The beach you are about to enter is a private beach with public access, therefore we need to adhere to the rules below if we are to continue to have this right to use it.
- Do not leave the boards on the beach, either laying down or leaning up against anything for any amount of time. If you're done paddle boarding please bring it back to the shop. You're welcome to enjoy the beach without the board.
- Thus you are only allowed to walk your board across the beach in/out of the water.
- Enter and exit only at the stairs and stay away from the condo building to the south.
- Do not leave boards leaning up against the wall blocking the path to the beach
- Do not go closer than 15 feet to the pilings with the gourd nests. There are endangered birds living in the nests.
- Please don't leave any trash and if you see any we have provided a trash can at the beach entrance.
- No dogs allowed
